| If a Driver, crew or participant is penalised under Rules 11.3, 11.4 or 11.5, they will be ineligible to hold, or apply, to be a member of AIDKA Executive or any delegate at an AIDKA sanctioned event for a minimum of 12 months from the conclusion of the penalty. Anyone wishing to apply or continue to hold an AIDKA position they must apply to AIDKA Council for consideration. |

| If any individual member is penalised under any AIDKA Behaviour Rules, they will be ineligible to hold, or apply, to be a member of the AIDKA Board, any AIDKA Sub Committee, be a club delegate or hold any official position at an AIDKA sanctioned event for a minimum of 12 months from the conclusion of the penalty. |



After the initial penalty has been served (not the additional period) any individual member considering applying to be a member or reinstate their position of the AIDKA Board, any AIDKA Sub Committee, be a club delegate or hold any official position at an AIDKA sanctioned event within the additional period applied must apply to AIDKA Board for approval prior to nominating for such a position.

Clearly explain the new rule/changes requested.

This is to put rule in line with the new AIDKA Regulations. The regulations were voted and implemented at AIDKA AGM December 2024. It was indicated in the regulations this would need to occur.

There has since been some discussions that the rule may be too harsh for minor offences and to be able to allow someone to volunteer or officiate at a meeting because of a minor offence for more than 12 months seems too harsh.

What situation/event/scenario has created this proposed rule change

Scenario was raised and different interpretations were made last year, hope this simplifies the wording.
