<p>9.5</p> <p>The Scrutineer(s) shall be responsible for checking the compliance of karts to these Rules of Racing. Each kart must be examined by the Scrutineer(s) and if satisfactory, marked to indicate compliance.</p> <p>a) Examine karts before practice/racing commences.</p> <p>b) Before a Driver is permitted to drive a kart (practice or racing) the driver must pay Nominations, sign in and confirm kart number (write in Drivers logbook) and have kart scrutineered by the official Scrutineer. All karts must be scrutineered, and number confirmed at scrutineering. It will be at the club's discretion if nomination or scrutineering done 1st. Preferred method to be posted on Clubs website.</p>

Proposed Rule**9.5**

The Scrutineer(s) shall be responsible for checking the compliance of karts to these Rules of Racing. Each kart must be examined by the Scrutineer(s) **if requested** and if satisfactory, marked to indicate compliance.

- a) ~~Examine karts before practice/racing commences.~~

Prior to practice/racing commences all probationary nominated drivers must have their karts scrutineered. The club may elect to scrutineer up to an additional three classes prior to practice/racing. Scrutineer(s) must conduct random checks on the out grid and/or in the pit area throughout the duration of a practice/race meeting. A competitor may request their own kart be scrutineered by an Official Scrutineer at any stage.

- b) Before a Driver is permitted to drive a kart (practice or racing) the driver must pay Nominations, sign in and confirm kart number (write in Drivers logbook) and have kart scrutineered **if requested** by ~~the an~~ official Scrutineer. ~~All karts must be scrutineered, and number confirmed at scrutineering.~~ It will be at the club's discretion if nomination or **required** scrutineering **is** done 1st. Preferred method to be posted on Clubs website. **Required classes to be scrutineered will be notified by notification via AIDKA App.**

Clearly explain the new rule/changes requested.

- This change is to try and save time at beginning of a race meeting and need for officials to spend extra time at a race meeting
- Limit need for competitor to be at a race meeting so early.
- Resources can be better utilised throughout the day for scrutineers to do random checks in between their races if needed.
- AIDKA Board have authorised some initial scrutineering trials at multiple clubs, and the feedback has been mostly positive.
- Data collected over the last 2 years shows that no incidents reported or insurance claims were due to a faulty or unsafe kart.
- Scrutineering as it is at present is only indicating the kart is compliant at time of inspection, this is in some cases up to 2 hours prior to racing.
- Larger meetings do not have the time to do a thorough scrutineer inspection in the time allocated at present meetings, this rule will allow for up to 3 classes to have a more detailed inspection by Scrutineers.
